The economic benefits of reducing nitrogen dioxide in Birmingham

Summary

CBI Economics analysis quantifies the potential gains to the health of Birmingham's workforce, and to the local economy, that could be achieved through a reduction in nitrogen dioxide (NO_2) levels via the proposed Clean Air Zone (CAZ). Just a small reduction in NO_2 of 5μ g/m³ (16%) could prevent 50 deaths and save 150 days spent in Birmingham's hospitals due to respiratory conditions each year.^{1,2}

Moreover, adding 216,000 working hours each year through increased workforce participation could provide an economic boost of more than £2.7m in Gross Value Added (GVA).³

Air quality matters to the health of our citizens and ultimately to our economy

Air pollution impacts human health and the productivity of the UK workforce, which in turn impacts the economy. Analysis conducted by CBI Economics in 2020 estimated that clean air in line with the World Health Organisation's (WHO) guidelines could deliver a £1.6bn boost to the UK economy each year.⁴

Evidence shows a key link between NO_2 and health outcomes. Reducing NO_2 therefore has a key role to play in realising this economic potential. NO_2 exposure leads to both short-term and long-term health impacts, exacerbating respiratory conditions such as asthma, possibly increasing the likelihood of lung cancer, stroke, and cardiovascular disease, and has been linked to adverse birth outcomes. This comes at a cost to the healthcare system. Public Health England estimates that between 2017 and 2025 the total cost to the NHS and social care system due to NO_2 alone will reach £61m. $^{6.7}$

The role of Clean Air Zones

Vehicles are the largest contributor to NO_2 pollution at roadsides, contributing 80% of the total. This means higher levels of NO_2 are typically focused in high traffic areas within city centres. Targeted local action, in addition to a national strategy, is therefore a key part of the government's solution to tackling NO_2 levels in the UK.⁸

While the government has considered a range of policy options, the evidence concludes that CAZs are the most effective measure to reduce NO₂ levels within the legal limits in the shortest possible time.⁹ As a result, the government has mandated several cities to implement CAZs, including Birmingham.

Nitrogen dioxide levels in Birmingham

The UK has statutory limit values for the annual and 1-hour mean concentrations of NO_2 , set at $40~\mu$ g/m³ and $200~\mu$ g/m³ respectively. Analysis by Ricardo Energy and Environment (Ricardo) finds that while on average NO_2 concentrations in Birmingham comply with the annual limit value, the maximum annual concentration across locations in Birmingham in 2019 exceeded this by almost 40% (15 μ g/m³). This exceedance is driven by 17 locations, predominantly found in and around the city centre, bounded by the A4540 Middleway Ring Road. This increases to 34 locations when including those just below the limit value, including locations on the motorway in the northern part of Birmingham, and some on the A47 approaching the motorway.

Birmingham's proposed Clean Air Zone

Birmingham City Council is introducing a CAZ on 1 June 2021. This will be complemented by additional measures to address the largest contributors to NO_2 exceedance in the hotspot areas identified, particularly diesel Large Goods Vehicles (LGVs) and Rigid Rail Guided Vehicles (RGVs), as well as buses and coaches. These additional measures are informed by a feasibility study which showed the reduction in NO_2 emissions from the CAZ alone would be insufficient to bring concentration levels down to legislative values. The CAZ will cover the roads inside the A4540 Middleway Ring Road – an area which includes the city centre, where most areas of NO_2 exceedance can be found, as well as other locations on major roads in and around the city centre. 20,21

Evidence from feasibility studies conducted across a range of cities suggests that introducing a CAZ D, thereby reducing the number of polluting vehicles entering the area, could reduce NO_2 concentrations by 5 μ g/m³. This means Birmingham would achieve compliance with national limits up to four years earlier than expected. As road transport accounts for approximately 20% of carbon emissions in Birmingham, the introduction of a CAZ is also expected to contribute towards the city's objective of a 60% reduction in carbon emissions by 2027.

CBI Economics analysis estimates that lower NO₂ levels could prevent at least 4% of Birmingham's deaths associated with respiratory conditions each year

Birmingham has a young and vibrant population. Almost two thirds (64%) of Birmingham's population are of working age compared to an average of 62% in England and Wales.²⁵ Of these, 67% are currently in employment, and therefore improving the health of Birmingham's workers could result in a significant gain to the local economy.²⁶

Evidence shows the impacts of poor air quality fall disproportionately on the elderly, who are more likely to be outside the working population. In Birmingham 88% of deaths associated with respiratory diseases fall within the over-65 age bracket.²⁷ The remaining 12% of deaths are among working-age residents with long-term conditions, 55% of which are economically inactive or unemployed.²⁸

In Birmingham, 14% of all deaths and 7% of hospital admissions in 2019 were due to respiratory conditions. A further 24% of deaths in 2019 were due to circulatory and heart conditions, and 5% due to malignant cancers, all of which are also to an extent attributable to air pollution. Reducing NO_2 levels could therefore prevent some premature deaths and reduce hospital admissions.

CBI Economics analysis finds that a 5 μ g/m³ reduction in NO $_2$ in Birmingham could, at a minimum, prevent between 24 to 52 deaths each year, and save 150 days spent in hospital due solely to NO $_2$ exposure.³¹ This represents around 4% of Birmingham's deaths associated with respiratory conditions.³²

The final health benefits of reducing NO_2 are likely to be far greater

As it was not possible to quantify all impact channels, the resulting health benefit is expected to go far beyond this.³³ The reasons for additional health benefits is due to the following:

- A larger share of the UK's population will be exposed to cleaner air than just those living inside Birmingham's Ring Road: Around 67,000 people (5% of Birmingham's residents)³⁴ live within the CAZ boundary, but many others will travel through the CAZ for work, study or leisure, including 68,000 students across the city who live, shop, or socialise within the CAZ boundary.³⁵ Around 177,000 of Birmingham's workers (39%) live outside of the city and commute into the CAZ area for work.³⁶ In addition, Birmingham sees an average annual inflow of 28m visitors, 91% of which are day visitors who are likely to visit multiple times during the year for shopping or leisure.³⁷ A larger group of the UK's population would therefore benefit from cleaner air than the analysis captures.³⁸
- Improving air quality will reduce a host of primary health conditions associated with air pollution: The main conditions associated with air pollution are respiratory conditions, cardiovascular disease, and lung cancer, but there is emerging evidence of associations with low birth weight and Type 2 diabetes. These conditions may be more closely linked with other pollutants, such as PM_{2.5}, but NO₂ exposure is likely to play a role within a wider mix of air pollutants. As this analysis is only focused on respiratory conditions, it underestimates the overall impact of lower NO₂ on all health outcomes related to air pollution.
- Improving air quality will reduce health conditions where air pollution is a secondary factor: Exposure to air pollution can also suppress lung function growth in children, and in adulthood it can accelerate the decline in lung function with age. This increases the risk of death from other primary conditions. For example, COVID-19 patients that already suffer from long-term respiratory conditions are at greater risk of death. As a result, improvements in air quality will have knock-on impacts on other health outcomes in addition to those direct impacts captured by the analysis.
- Reducing emissions from vehicles is expected to lead to a reduction in other pollutants: Evidence suggests NO₂ is emitted with other pollutants, especially PM_{2.5}, which makes it difficult to determine NO₂ as the attributable pollutant to health outcomes.⁴³ In addition, road transport has been linked to other pollutants including PM_{2.5}, PM₁₀ and ground level ozone, which means CAZs could lead to a reduction in other pollutants.⁴⁴ These reductions could therefore provide further health benefits not captured by this analysis. Since PM_{2.5} is the largest determinant of health outcomes due to air pollution, this omission could be significant.^{45,46}

CBI Economics analysis estimates that bringing NO_2 within legal limits will add £2.7m to Birmingham's economy each year through increased workforce participation

Despite a disproportionate impact of air pollution on non-working residents, there is still expected to be a large impact on the working population. Analysis by CBI Economics shows that a healthier workforce in Birmingham could result in an additional 101,000 to 216,000 hours worked.⁴⁷

Assuming full employment, meaning that these extra hours can be put to immediate use, this could increase the total production in the economy by an additional £2.7m in GVA from preventing these health outcomes.

The final economic benefit to Birmingham is likely to be much larger

The resulting economic benefit is expected to go beyond £2.7m GVA, not only because the resulting health impacts are expected to be larger than it is possible to quantify, but also for the following reasons:

- The resulting days lost from work in the event of a hospital admission will be higher than just the days spent in hospital: Prior to a hospital admission, it is likely that an individual will already have been suffering and will also likely require time to recover, increasing the days lost from work over and above the time spent in hospital. However, this analysis only quantifies the impact of a reduction in NO₂ on the time spent in hospital due to limited availability of academic evidence.⁴⁸
- The value of unpaid work not carried out as a result of conditions related to NO₂ emissions cannot be estimated: Activities taken outside of formal employment are estimated to be a significant contributor towards the UK economy: the ONS estimated unpaid work at 60% of GDP in 2016.⁴⁹ For example, activities such as volunteering and unpaid social care also add value to the local economy but are not captured in this analysis. As a result, cost-benefit analyses on air pollution often seek to include this as an impact pathway for quantification.⁵⁰ However, it was not possible to quantify this as part of this analysis due to an absence of academic evidence solely for NO₂.

While the reduction in NO_2 emissions will be concentrated inside the Middleway Ring Road, the benefits are likely to extend to the wider Birmingham population and outside of Birmingham's boundaries as many who live outside of the CAZ area travel into the CAZ for study, leisure, shopping, or work. Lower NO_2 levels can therefore provide benefits beyond the localised effects and can be an engine for a healthier and more prosperous city.

- 2. The number of deaths and hospitalisations will not stay the same as the years go on because of changes in population size and age structure as the deaths prevented accumulate over time. However, given this is a static analysis, the population and employment levels are assumed constant.
- 3. Real Gross Value Added (GVA) Chained Volume Measures (2016 prices), i.e. accounting for the effect of inflation by using 2016 prices as the reference case. The figures refer to 2018. GVA is the value generated by any unit engaged in the production of goods and services. This includes the compensation of employees (wages and salaries, bonuses etc.), taxes (less subsidies) on production, and gross operating profits (including self-employment earnings) associated with the production a given level of output.

- 10. Statutory limit values are legally binding and must not be exceeded. In the case of NO_2 this is $40 \mu \text{ g/m}^3$ for the annual mean and $200 \mu \text{ g/m}^3$ for the 1-hour mean. In order for the UK to comply with the limit value, all local areas across the UK must be in compliance.

TG(16) (Defra, 2018) states that the error of concentrations produced from air quality models should be within 10% of the limit value. Therefore for NO_2 the error in modelled concentrations should be 4 μ g/m³, which means setting the limit value to 36 μ g/m³ takes into account error in the model.
- 14. The annual mean NO₂ concentrations are calculated by taking the average of the annual mean using monitoring data and the PCM roads model for roadside locations. While the hourly concentrations are measured by analysing the relationship between the annual mean and 1-hour maximum based on a regression equation.

alone would not bring compliance by 2020, so supplementary interventions alongside the charging CAZ were introduced in their Full Business Case in an aim to reduce the impacts of the scheme on residents, visitors, and businesses in Birmingham. These include additional measures for parking and network changes, as well as financial measures to support drivers most significantly affected: for example, packages for car, van and taxi owners who liver or work within the CAZ, a HGV and coach compliance fund, support for fleet upgrades to taxi and PHV vehicles, as well as to hydrogen buses, and a residents parking scheme.
